Guns and Arrows Campout – Friday, Sept. 25, 3:45 p.m. through Sunday, Sep 27, 2:00 p.m.

This event will be held at BSA Camp Potomac in Oldtown, MD. LP Scout for this trip is Joe Shirey. The camp has rifle, shotgun, and archery ranges. All Scouts will receive formal instruction and will be closely supervised via standard NRA and BSA regs. The Troop will be using its own equipment. The rifles are standard single shot .22 caliber bolt action weapons. We have a wide variety of sizes, including sizes suitable for very small Scouts and some left-handed rifles. The shotguns are high quality 12-gauge weapons, manually operated. The bows are standard recurve 10, 20 and 30 pound draws. Indoor cot or bunk sleeping will be available for adults. The Paw-Paw Tunnel Hike will be featured for Junior Scouts. **Scouts will need to pack their FULL SCOUT UNIFORMS for Mass.** Attending Scouts will receive a camp patch. **All Scouts should have \$10.00 cash IN HAND for dinner Friday.** Scouts should pack per car camping packing list on Troop website. Arrive at 3:45 p.m. Friday for 4:00 p.m. departure. Additional information will be published in the Primer the week of September 13, 2009.
